1. The vehicle should be registered with the transport authority as a commercial vehicle holding taxi permit along with all valid documents such as valid insurance, road tax etc. The driver should possess valid driving license, should be well mannered/disciplined, should have knowledge of Ernakulam city at least and adequately educated to maintain logbook.
2. The rates are to be quoted for hiring on monthly basis.
3. The kilometre counting of the vehicle shall start from the designated office and shall end at the designated office.
4. Upkeep, maintenance, and repair of the vehicle shall be the responsibility of the service providers.
5. Payment of monthly bill shall be made within one month of the presentation of the bill.
6. Department shall not be responsible for any damage to the vehicle in case of an accident or otherwise, theft of vehicle/parts and accessories therein. Similarly department shall not be responsible for any third party claim.
7. Service Tax, Toll, parking charges shall be payable over and above the quoted charges but the service provider shall have to produce proof of payment of such taxes and charges.
8. In case any vehicle provided to Department is not available due to repair, mechanical failure/accident or otherwise, then it shall be the responsibility of the service provider to provide vehicle of equivalent or above make during such period.
9. The service contract will be valid upto 31/03/2010 subject to satisfactory performance of the service provider. The Contract can be terminated without assigning any reason before 31/03/2010.
10. No extra charges other than the quoted value and charges as indicated in this notice shall be payable in any circumstance.
