Rates of Dearness Allowance applicable w.e.f. 1.7.2014 to employees of Central Government and Central Autonomous Bodies continuing to . draw their pay in the pre-revised scale as per 5th Central Pay Commission.

The undersigned is directed to refer to this Department's Office Memorandum of even No. dated 22<sup>nd</sup> April, 2014 revising the rates of Dearness Allowance in respect of employees of Central Government and Central Autonomous Bodies who continue to draw their pay and allowances in the pre-revised scales of pay as per 5th Central Pay Commission.

- The rates of Dearness Allowance admissible to the above categories of employees 2. of Central Government and Central Autonomous Bodies shall be enhanced from the existing rate of 200% to 212% w.e.f. 1.7.2014. All other conditions as laid down in the O.M. of even number dated 3<sup>rd</sup> October, 2008 will continue to apply.
- The contents of this Office Memorandum may also be brought to the notice of the organizations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.
