Sir,

Sub: Filling up the existing vacancies allotted to Central Excise Commissionerate under 25% quota for posting at Indira Gandhi International Airport, Delhi & Anna International Airport, Chennai – Reg.

Willingness is invited from Superintendents & Inspectors against the posts of Air Customs Superintendent & Air Customs Officers allotted to Central Excise Commissionerates at Indira Gandhi International Airport, Delhi and Anna International Airport, Chennai in Airpool against 25% quota. The selection will be done by a Departmental Selection Committee which will forward the panel of the names of officers to the concerned Chief Commissioner of Customs of the above Airports for further action. The terms & conditions for selection and posting at are as follows:-

- 1. The officer posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them from time to time.
- 2. He/She shall be considered as on deputation to the Airport, but no deputation allowance is admissible to him / her.
- 3. Normally, the period of deputation at the Airport is two years. However the same can be extended by one more year, subject to the willingness of the officer and its acceptance by the Chief Commissioner concerned having jurisdiction of the International Airport to which the officer is assigned.
- 4. The officer posted at the Airport will have to make his / her own arrangements for residential accommodations.
- 5. The officer will also be entitled to draw uniform and diet allowance as admissible under rules.
- 6. In the event of their promotion to the higher grade the officer will be liable to be reverted back to their parent Commissionerate or posted anywhere as may be ordered by the competent authority in this regard.

The following officers are not eligible for consideration for posting:-

- a. Officers transferred out of Airport / sensitive places on administrative grounds.
- b. Officers due for retirement upto 31.12.2016.
- c. Officers with less than 2 years cooling off period on their return from Airpool / U B Centres / DGRI / DGAE / NCB / ED (FERA)/EIB in terms of Ministry's instructions issued under F.No.A-35017/28/92-Ad.IIB dated 30.06.94.
- d. Officers with Vigilance / Non-Vigilance cases
- e. Officers against whom penalty is operative.

Officers willing to apply for the above posts are directed to fill the enclosed bio-data form. Willingness / Bio-data of the eligible officers should reach Central Excise Hqrs. office, Cochin positively by **28-02-2013.** Willingness received after the stipulated date will not be entertained.
