Sub: Posting of Air Customs Superintendent to AP, Trivandrum and Cochin International Airport, Nedumbassery against 25% Quota - Reg.

Willingness is invited from Superintendents against the posts of Air Customs Superintendent allotted to Kerala Central Excise Zone at Airport Trivandrum and Cochin International Airport, Nedumbassery in Airpool against 25% quota. The terms & conditions for selection and posting at above Airport, postings are as follows:-

- 1. The officer posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them from time to time.

- 6. In the event of their promotion to the higher grade the officer will be liable to be reverted back to their parent Commissionerate or posted anywhere as may be ordered by the competent authority in this regard.

- Officers with less than 2 years cooling off period on their return from Airpool / U B Centres / DGRI / DGAE / NCB / ED (FERA)/EIB in terms of Ministry's instructions issued under F.No.A-35017/28/92-Ad.IIB dated 30.06.94.
- Officers with Vigilance / Non-Vigilance cases d.
- Officers against whom penalty is operative. e.
