TERMS AND CONDITIONS FOR TENDER NOTICE NO. /2013

- 1. The bidder shall be 'A' grade electrical contractor and having at least five years experience in the said field. The experience certificate and client list have to be enclosed alongwith tender.
- **2.** In the quotation, Bidder shall mention Director's/ Partner's/ Proprietor's name alongwith complete postal address and telephone/ mobile/ fax no. of the firm.
- **3.** He shall, inter alia, clearly mention the bid amount separately for each type of work mentioned in the tender notice.
- **4.** The document containing bids shall be free from cutting and overwriting. However, alterations may be attested properly by the authorized signatory of the firm. All the documents submitted including tender document shall be duly certified by the authorized signatory of the firm.
- **5.** The quotations are liable to be rejected if conditions are not complied with. Commissioner, Customs (Preventive), Kochi may accept or reject any quotation without assigning any reason whatsoever. In case of any dispute, the decision of the Commissioner, Customs (preventive), Kochi shall be final and binding on the bidders.
- **6.** Successful bidder shall provide service/warranty of installed against any breakage/breakdown from twenty-four months from the date of said work. In the event of item being found obsolete/unworkable due to poor quality/installation, the bidder shall replace the item immediately, if such defect is reported to him within twenty-four months from the date of installation. Any default in such servicing/replacement will cause black listing of firm.
- 7. Successful bidder will be issued work order, whereby some more information/ documents may be sought by this office. Successful bidder shall submit the same immediately from the date of receipt of the work order. This office shall be at liberty to ask for earnest money deposit/ bid. Security any time from successful bidder amounting from two percent to five percent of the bid value.
- **8.** Upon receipt of work order, work has to be completed within fifteen days. Upon completion of work, the firm shall bill/ invoice in triplicate duly pre-receipted by the authorized signatory.
- **9.** Payment will be made after successful and satisfactory completion of the work as per the tender.
- 10. Furnishing wrong information/ record/ document and not complying with the terms and conditions attached with the tender process cause black listing of firm.
