- 2. They will be on probation for a period of two years from the date of appointment. The appointing authority may, if she thinks fit, extend the period for probation.
- 3. If on expiry of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that they are not fit for permanent absorption or if at any time during such period of probation or extension

thereof, is satisfied that they will not be fit for permanent absorption on the expiry of such period or extension, the appointing authority may terminate their services or pass such orders as she thinks fit.

4. The above candidates are also informed that their appointment is provisional and is subject to the SC / ST / OBC certificates being verified through proper channel and if the verification reveals that the claim to belong to SC / ST / OBC or in the case of OBC, not to belong to 'Creamy Layer' as the case may be, is false, his/her service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code or any other Act, for the time being in force, for production of false certificates (applicable in respect of SC/ST/OBC candidates).
