- 2. The conditions of appointment are enumerated in the **Annexure**. If they accept the offer of appointment on the basis of the stipulated conditions, they should report for joining the post of Inspector of Central Excise on or before 30.03.2016 before the Commissioner, Central Excise Hqrs., Central Revenue Building, I. S. Press Road, Cochin-18. If the candidate fails to report for duty within the prescribed time, it will be presumed that he/ she is not interested in accepting this offer of appointment and the offer of appointment will be cancelled without further notice.
- 3. The above individuals will be considered to have joined service from the date on which they actually join duty. They are liable to be transferred anywhere in India.
- 4. No travelling allowance will be allowed for joining on appointment.
- 5. At the time of joining they should bring the following documents in original:
 - a) Documentary evidence in support of Date of Birth.
 - b) Documentary evidence in support of Educational Qualification. (If not already submitted)
 - c) Caste Certificate in case of SC/ST/OBC in original (only in the prescribed form) if not already given.
 - d) Discharge Certificate and certificate of good conduct from the employer in case the candidate is employed in any of the Offices under the State / Central Government/Public Undertakings presently. The certificate should be obtained with reference to this Offer of Appointment.
 - e) Copy of Aadhaar Card (if not submitted earlier).
- 6. The candidate will be on probation for a period of 2 years from the date on which he/ she reports for duty subject to successful passing of Departmental Examinations and other requirements. The appointment is provisional and is subject to the verification of Character and Antecedents, SC/ST/OBC Certificate being verified through proper channel. If the verification reveals that the claim to belong to SC/ST/OBC or in the case of OBC, not to belonging to 'Creamy Layer' as the case may be, is false, his/her service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificates (applicable in respect of SC/ST/OBC candidates).
