- 3. If on the expiration of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that they are not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that they will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate their services or pass such orders as he thinks fit.

The above candidates are also informed that their appointment is provisional and is subject to the caste/tribe certificate being verified through the proper channel and if the verification reveals that their claim to belong to SC/ST/OBC or in the case of OBC, not to belong to 'Creamy Layer' as the case may be, is false, their services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of the I.P.C. or any other Act, for the time being in force, for production of false certificate (applicable in respect of SC/ST/OBC candidates).
