Sub: - Modified Assured Career Progression Scheme (MACPS) for the Central Government Civilian Employees - reg.

Kind reference is invited to this office letter C.No.II/3/1/2016-conf.Cx dated 23.06.2016 addressed to all Commissioners in the zone on the above subject, of which a copy was published in the Departmental website.

- 2. In terms of DOPT instruction No. 35034/3/2008- Estt (D), all regularly appointed Group 'B', 'C'& 'D' officers are eligible for financial up-gradation under MACP scheme at regular intervals of 10,20 & 30 years of continuous regular service. Accordingly, the screening Committee constituted has been convening periodical meeting twice in every year to consider the cases for grant of financial up-gradation under the MACP scheme to the eligible officers.
- **3.** However, the Associations have represented that the names of few officers have not been considered by the screening committee for granting MACP upgradation. It is noticed that these omissions were due to the non-availability of the details in the prescribed pro-forma to be submitted by the incharge, Administrative Officer (DDO's).

4. To avoid such omissions in future, the jurisdictional Commissioners are requested to issue instructions to the Administrative Officer (DDO) under their jurisdiction to furnish the information in the prescribed pro-forma for grant of the financial up-gradation under MACP scheme in respect of all officers having completed 10, 20 & 30 years of regular service. The pro-forma in the prescribed format of the officers eligible during the period up to 31<sup>st</sup> March/31<sup>st</sup> July of every year shall be submitted to Superintendent (Confidential), Head quarters office, Cochin latest by 15<sup>th</sup> March/15<sup>th</sup> July of the same year after proper scrutiny at their level.

This is for strict compliance.
