Sub: Promotion to the cadre of Inspector of Central Excise- Reg.

In pursuance to Ministry's letters F.No. A.32011/03/2015-Ad III A dated 02.08.2016 and as per the recommendations of the Review DPC held on 12.06.2017, Smt.Sruthi Chandran (D.O.B.03.09.1989) Senior Tax Assistant (re-designated as Executive Assistant) is deemed to have been promoted w.e.f 05.04.2017, to officiate in the cadre of Inspector of Central Excise in level 7 of the Pay Matrix (Rs.44, 900-1, 42,400) as per 7th CPC corresponding to Pay Band of Rs. 9300-34800 plus Rs. 4600 (Grade Pay) plus such allowances as may be sanctioned by Government of India from time to time. Smt. Shruthi Chandran will be placed immediately below Shri Basil Philip and above Smt. Aswina Nair.

- 2. The officer should join the promoted post with immediate effect failing which it will be treated that she has not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
- **3**. The above promotion is subject to the outcome of litigations pending before CAT (EB) /High Court/Supreme Court.
- **4.** She has to exercise option for pay fixation under FR 22 1 (a) 1 within a period of one month of joining the new post.
- **5**. The seniority of the officer in the new cadre will be fixed and placed as per DOPT's guidelines and Board's instructions.

- **6**. Specific posting order to the officer will be issued in due course. The officer shall be liable to be transferred anywhere in the zone.
- **7.** Report compliance urgently.
