Sub: - Modified Assured Career Progression Scheme (MACPS) for the Central Government Civilian Employees - Regarding.

Please refer to the instructions issued from time to time with regard to the proposals for the grant of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> MACPS.

- 2. The Screening Committee for grant of MACPS could be conducted based on the proposals received in respect of the officers working in the field formations from the respective Divisions/ Commissionerate Hqrs. The proposals for grant of financial upgradation under MACP Scheme has to be submitted to Superintendent (Confidential) Hqrs. Office, Cochin in the prescribed proforma. It is noticed that the information furnished in respect of certain officers are at variance with the actual information available in the Service Book/ Dossier. These minor errors in the proforma have caused inconvenience while processing the proposal besides putting the concerned officer in an disadvantageous position for no fault of his.
- 3. With a view to streamline this item of work it is proposed to direct the AC/DC/AO/DDO of the concerned Divisions/Commissionerate Hqrs. to kindly ensure that the information furnished in respect on an officer is true and correct and consistent with the information available in the Service Book/Dossier. Sl. Nos. 10 (a) & 10 (b) of the proforma will be scrutinized and reported by the Superintendent (Vigilance) of the Hqrs. Office. The DDO and Administrative Officer in charge will ensure to furnish full details of the officer proposed by them and invariably mention the eligibility of the officer as per Sl. No. 14 of the proforma. If details of refusal of regular promotion (Sl. No. 9) are available with the respective DDO/AO's, they may specifically mention this fact.

4. It is requested that the particulars of Group 'B', 'C' and 'D' officers who are eligible for consideration for grant of benefits under the MACP Scheme during the period upto 31.03.2018 may be furnished so as to reach this office on or before 15.07.2017 in the proforma enclosed herewith. It is requested to circulate this letter to all the Deputy/ Assistant Commissioners in the respective Commissionerate.
