## ORDER NO. 165/2017

Sub: Representation of Shri. Francis P. M, Motor Driver (Grade II) for reversion to the grade of Havaldar – Reg

Shri. Francis P M, Motor Driver (Grade II) is transferred to the grade of Havaldar under FR – 15 (a) as requested by him vide his representation dated 11.05.2017.

- 2. This order will take effect only after Shri. Francis P. M furnishes an undertaking to the effect that:
  - **a.** He understands that he is being reverted on his own request and will lose lien over the post of Driver forthwith.
  - **b.** He understands that he will be considered to have resigned the post of Driver and will not be entitled to count his service on the grade of Driver for any purpose.
  - c. He is willing to be placed as junior most in the grade of Havaldars as on the date of joining.
  - **d.** His pay will be fixed as per the clarification issued by DOPT vide OM F.No.13/9/2009-Estt (Pay-I) dated 21.10.2009 & vide OM No.16/4/2012 Pay I dated 05.11.2012.
- 3. If he fails to furnish the undertaking as above on or before 11.08.2017, this order will be treated as cancelled.
