Sub: Appointment to the cadre of Havaldars on Compassionate Grounds - Reg

As per the findings of the Committee held on 08.11.2017 and on passing the physical test prescribed for Direct Recruit Havaldars, Shri. Akhil Thomas is appointed as Havaldar, on compassionate grounds in Central Tax and Central Excise, Thiruvananthapuram Zone under General category on temporary capacity, subject to verification of character and antecedents, in Level-1 in the pay matrix (Rs.18,000-56,900) plus such allowances as may be sanctioned by the Government of India with effect from 04.01.2018 (A.N).
