**Subject: Special "ITC" Refunds Drive-Reg.**

Consequent to the successful Special Drive on Export Refunds during the month of March, 2018, the Department is organising a **"Special Drive on ITC Refunds"** from **31<sup>st</sup> May, 2018 to 14<sup>th</sup> June, 2018**. As part of the drive, all the claimants are requested to approach their jurisdictional Tax Offices during the **Special Refund Fortnight** to clear any pending GST Refund Claims, which were submitted on or before **30.04.2018**. It is also brought to the notice of claimants that refund application in Form GST RFD-01A will not be processed unless a copy of the application is submitted to the jurisdictional tax office alongwith supporting documents.

In this regard, attention is invited to Circular No.45/19/2018-GST dated 30.05.2018 issued by the Central Board of Indirect Taxes and Customs.

All the Trade, Commerce and Industry Associations, Exporters, Importers are requested to bring the contents of this Trade Notice to the notice of their members for information and necessary action.
