This is to inform you that the Sanctioned Strength of GST/Central Excise Superintendents on deputation to C.S.I. Airport, Mumbai is 54. However, only 20 Superintendents are presently working on deputation from various GST/Central Excise Commissionerates leaving 34 vacancies.

Similarly, the Sanctioned Strength of GST/Central Excise Inspectors for deputation to C.S.I. Airport, Mumbai is 69. However, only 09 Inspectors are presently working on deputation from various Central Excise Commissionerates leaving 60 vacancies.
