ESTABLISHMENT ORDER NO. 78/2020

Sub: Appointment to the cadre of Stenographer Grade-II - Reg.

On acceptance of this Central Tax & Central Excise Commissionerate's Offer of appointment of even no. dated 23.07.2020, Kum. Renu Yadav, a candidate nominated by the Ministry for provisional appointment as Stenographer Grade-II (selected under OBC category and provisionally allocated against the general vacancy) vide F.No.A.12034/SSC/15/2017-Ad.III (B) dated 29.06.2020, is provisionally appointed as Stenographer Grade-II in Central Tax & Central Excise, Thiruvananthapuram Zone on temporary capacity, subject to verification of character and antecedents, in Level - 4 in the pay matrix (Rs.25,500-81,100) plus such allowances as may be sanctioned by the Government of India with effect from 27.08.2020 (F.N).

- Kum. Renu Yadav is informed that she will be on probation for a period of two years from the date of appointment. The Appointing Authority may, if he thinks fit, extend the period of probation.
- If on the expiration of the period of probation or any extension thereof, as 3. referred to in Para 2 above, the appointing authority is of the opinion that the above candidate is not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that she will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate her services or pass such orders as he thinks fit.
- The above candidate is also informed that her appointment is provisional 4. and is subject to the caste/tribe certificate being verified through the proper channel and if the verification reveals that her claim to belong to SC/ST/OBC or in the case of OBC, not to belong to 'Creamy Layer' as the case may be, is false, her services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of the I.P.C. or any other Act, for the time being in force, for production of false certificate (applicable in respect of SC/ST/OBC candidates).

- 5. It is pertinent to mention here that your appointment shall purely be provisional/temporary and liable to be terminated on short notice. The appointment shall be subject to the final decision of the DOP&T on the issue.
