The Directorate General of Goods & Services Tax (DGGST), Eastern Zonal Unit, Kolkata is in the process of drawing up a panel to fill up the posts of Additional Assistant Director, Inspector, Administrative Officer and Ministerial Staff in the Directorate General of Goods & Services Tax, Eastern Zonal Unit, Kolkata on deputation basis as mentioned below. It is proposed to fill the vacancies by appointing suitable officers holding analogous posts in the formations of Central Goods & Services Tax and Customs formations.

2. The officers selected for the posts will be entitled for Deputation Allowance as admissible in terms of Office Memorandum No.2/11/2017-Estt(Pay.II) dated 24.11.2017 of Ministry of Personnel, Public Grievances and Pensions, DOP&T, New Delhi.

- 3. The deputation is for a period of five years for the above mentioned posts, which is extendable by another two years, one year at a time, subject to the willingness of the officer, his/her performance, concurrence of his / her parent Commissionerate and approval of the Competent Authority.
- 4. It is requested that this communication may kindly be circulated among the officers in your jurisdiction and the applications of the willing officers may kindly be forwarded to this Directorate. Officers may be advised that willingness once exercised cannot be withdrawn later on and they are expected to serve in DGGST, Eastern Zonal Unit till the expiry of their tenure of 5 years. While forwarding the names of the willing officers, the following information in respect of them may also be sent for evaluation by this Directorate:-
- [a] Complete bio-data viz. Name, date of birth, educational qualification, present post and the date from which it is held including history of postings;
  - [b] willingness of the officer;
  - [c] ACR/APAR grading for the last 5 years duly verified;
  - [d] Vigilance Clearance Certificate;
- [e] No Objection from the Cadre Controlling Authority to relieve the officer / staff in the event of his/her selection.
- 5. In case, while working in this Directorate, if the conduct and work of the officer is not found satisfactory, the officer shall be reverted back to the parent Commissionerate prematurely without assigning any reasons.

- 6. The last date of receipt of applications is 18-12-2020.
- 7.
