On acceptance of this Central Tax & Central Excise Commissionerate's Offer of appointment of even no. dated 01.10.2021, Shri. Pathayathil Satheesh Kumar, a candidate allocated by the Ministry for appointment as under **UR-EXS** category vide letter Tax Assistant File No.A-12034/SSC/02/2018-Ad.III.B dated 15.09.2021 is appointed as Tax Assistant in Central Tax & Central Excise, Thiruvananthapuram Zone on temporary capacity, subject to verification of character and antecedents, in Level – 4 in the pay matrix (Rs. 25,500-81,100) plus such allowances as may be sanctioned by the Government of India with effect from 29.10.2021 (F.N).

- **2. Shri. Pathayathil Satheesh Kumar** is informed that he will be on probation for a period of two years from the date of appointment. The Appointing Authority may, if he thinks fit, extend the period of probation.
- **3.** Before the expiry of the period of probation or any extension thereof, as referred to in Para 2 above, if the appointing authority is of the opinion that **Shri. Pathayathil Satheesh Kumar** is not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that he will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate his services or pass such orders as he thinks fit.
- **4.** The above candidate is informed that his appointment is provisional and is subject to the caste/tribe certificate being verified through the proper channel and if the verification reveals that his claim to belong to SC/ST/OBC or in the case of OBC, not to belong to 'Creamy Layer' as the

case may be, is false, his services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of the I.P.C. or any other Act, for the time being in force, for production of false certificate (applicable in respect of SC/ST/OBC candidates).
