In terms of the provisions of Rule 48-A of CCS (Pension) Rules, 1972, the Commissioner of Central Tax and Central Excise, Kochi is pleased to permit Smt. Raji K.R., Superintendent, CPD Thrissur, Customs Preventive Commissionerate to retire voluntarily from Government Service with effect from **31.10.2022 A.N** subject to all relevant conditions as applicable to Government servants under Voluntary Retirement Scheme pursuant to her representation dated 14.10.2022.

- 2. It is informed that her request to relax the requirement of notice of three months period has been accepted by the competent authority, subject to the condition that the Government servant shall not apply for commutation of a part of her pension before 14.01.2023 (i.e, the date of expiry of the period of notice of three months).
