Sub: Voluntary retirement from service in respect Shri Sathes Kumar P, Superintendent, Ernakulam Division, Kochi Commissionerate - reg.

In terms of the provisions of Rule 48 of CCS (Pension) Rules, 1972, the Commissioner of Central Tax and Central Excise, Kochi is pleased to permit Shri Sathes Kumar P, Superintendent, Ernakulam Division, Kochi Commissionerate to retire voluntarily from Government Service with effect from 31.08.2023 A.N subject to all relevant conditions as applicable to Government servants under Voluntary Retirement Scheme pursuant to his representation dated 05.06.2023.

It is informed that competent authority has relaxed the requirement of notice period of three months, subject to the condition that the Government servant shall not apply for commutation of a part of his pension before 05.09.2023 (i.e., the date of expiry of the period of notice of three months).
