
ORDER NO. 02 /2015

Sub: - Estt. - Voluntary retirement from service in respect of Shri A Austin Antony, Head Havaldar, Ernakulam II Division – Reg.

Shri A Austin Antony, Head Havaldar, Ernakulam II Division vide representation dated 05.12.2014 has requested to permit him to retire voluntary from service w.e.f. 31.01.2015.

2 In terms of the provisions of Rule 56(k) of CCS (Pension) Rules 1972, the appropriate authority is pleased to permit Shri A Austin Antony, Head Havaldar, Ernakulam II Division to retire voluntarily from Government Service with effect from **01.02.2015 (FN)** subject to all relevant conditions as applicable to Government servants under Voluntary Retirement Scheme. However, since Shri A Austin Antony, Head Havaldar has not given the necessary three months notice period, the appropriate authority has waived off the notice period of three months in terms of Sub-Rule 1-A (b) of Rule 56 (k) of CCS (Pension) Rules 1972 subject to the condition that the officer shall not apply for commutation of a part of his pension before the expiry of the period of notice of three months i.e. not before **05.03.2015**.

3 All dues in respect of Shri A Austin Antony, Head Havaldar may be recovered from his retirement benefits as per rules.
