Subject: Dispute in the seniority list of Inspectors as on 01.01.2007-Representation dated 10.11.2014 filed by Sri M.Krishnan kutty, Inspector of Central Excise (Retd) – reg.

2. Your representation has been examined in detail. Records show that a Departmental Promotion Committee (DPC) was held on 08.11.2002 for considering promotion of Tax Assistants/UDCs/Steno Gr II/Steno Gr. III for the 227 vacancies in the cadre of Inspector of Central Excise. The committee was informed that for promotion to the cadre of Inspector, the candidates will be required to possess physical standards and pass the requisite physical endurance test and qualify in the written test with the prescribed percentage of marks and conform to the age limit as specified in the draft recruitment rule 2002. Note:2, Column 12 of the Central Excise and Land Customs Department Inspector (Group 'C' posts) Recruitment Rules, 2002 provided that the maximum age of eligibility for the departmental candidates shall be

Committee recommended the following panel of officers for promotion to the grade of Inspector of Central Excise against 131 vacancies that remained unfilled as on 7.12.2002.

- 5. Your seniority was re-assigned as per the findings of the Review DPC held on 14.02.2006. The DPC observed that you were not eligible for promotion in accordance with the old Recruitment Rules -1979 as you had crossed 45 years of age as on 1.1.2002 and that you were eligible for promotion in accordance with the Recruitment Rule, 2002 wherein the upper age limit was relaxed upto the age of 50 years. Hence your juniors in Seniority list of TA/UDC as on 01.01.2002 who were eligible for promotion as per the Recruitment Rules,1979 prior to 7.12.2002 were placed above you in the Seniority list of Inspector as on 01.01.2007 communicated vide C.NO. II/39/09/2007-Estt I dated 05.12.2007.
- 6. In view of the above, your representation does not merit consideration.
