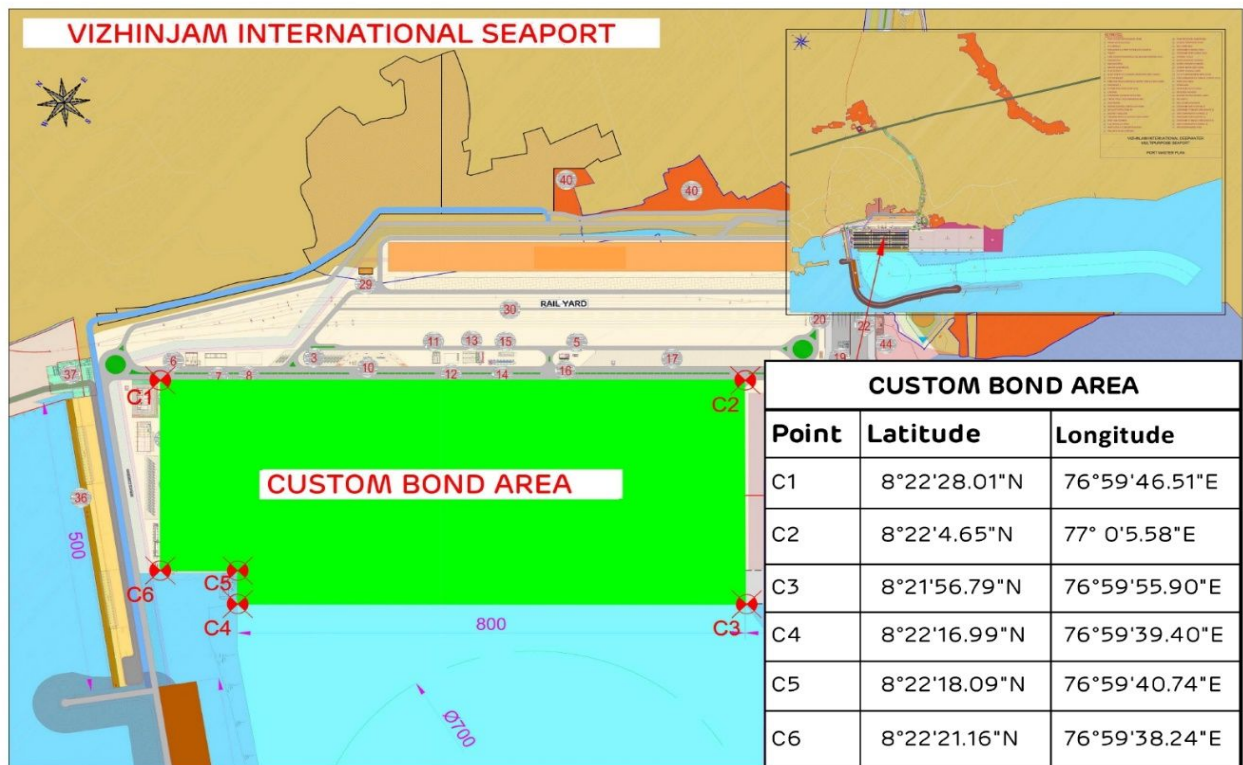
Notification: 02/2024 - CCP Cochin

Whereas, the Vizhinjam International Seaport has been notified as Customs Port under Section 7(1)(a) of the Customs Act, 1962 vide Notification No. 42/2024-Customs (N. T.) dated 12.06.2024 for unloading of imported goods and loading of export goods or any class of such goods;

2. In exercise of the power conferred upon me under Section 8 of the Customs Act, 1962, I, K Padmavathy, Commissioner of Customs (Preventive), Cochin in supersession of the Notification No.01/2024 – CCP Cochin dated 24.06.2024, hereby approve proper places at Vizhinjam International Seaport under Section 8(a) of the Customs Act, 1962 which co-ordinates are mentioned below in the Schedule - I for unloading of imported goods and loading of export goods subject to strict observation of the provisions of the Customs Act, 1962 and instructions issued by the Government of India from time to time.

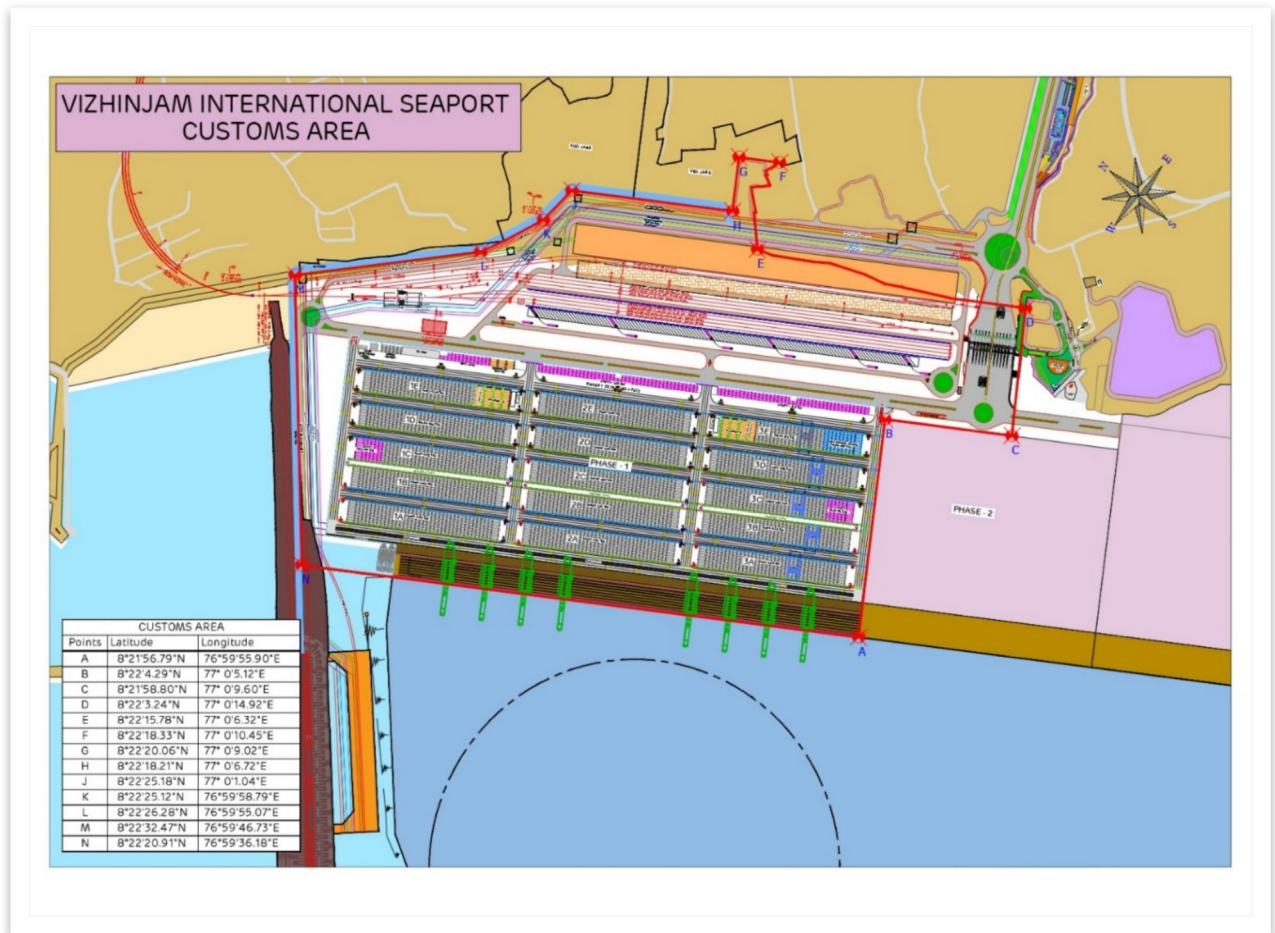
