You are a candidate sponsored by the Staff Selection Commission for appointment to the post of Inspector of Central Excise, in the Central Excise Department, Kerala Zone. As you have to undergo the physical standard / endurance test prescribed for selection of Inspectors of Central Excise, you are directed to report before the Superintendent of Central Excise, Hqrs. PRO Unit, Office of the Commissioner of Central Excise, Customs & Service Tax, CR Building, I.S. Press Road, Cochin - 682018. Kerala State.

You should report at 10 AM on 25.11.2013

The physical standards and endurance tests prescribed for the post of Inspector of Central Excise are given below:

(A) PHYSICAL STANDARD

FOR MALE CANDIDATES

1. Height - 157.5 cms. - Relaxable by 5 cms in case of Assamese, Garwali & Gorkhas and members of the ST.
2. Chest - 81 cms. - Fully expanded with a minimum expansion of 5 cms.

FOR FEMALE CANDIDATES

1. Height - 152 cms. - Relaxable by 2.5 cms. For Gorkhas, Garwalis, Assamese and members of ST.
2. Weight 48 Kgs. - Relaxable by 2 Kgs. For Gorkhas, Garwalis, Assamese and members of ST.

(B) ENDURANCE TEST

FOR MALE CANDIDATES

1. Walking - 1600 Mtrs. in 15 Minutes.
2. Cycling - 8 Kms. in 30 Minutes.

FOR FEMALE CANDIDATES

1. Walking - 1 KM in 20 Minutes
2. Cycling - 3 Kms. in 25 Minutes.

You should make your own arrangement for procuring bicycle for undergoing the Cycling test.

You are required to bring the following documents with you for verification:

1. Matriculation / Higher School Certificate showing Date of Birth.
2. All other Academic Certificates showing Educational Qualifications and also subjects studied at various levels.
3. Certificates in support of your claim regarding experience and Certificates about Extra-Curricular Activities.
4. Certificates in support of your claim as SC/ST/OBC/EX-Service/ PH if applicable.

You are required to fill in the attestation form, (in triplicate) enclosed with this call letter and bring it with you.

You are required to undergo the prescribed Medical examination and to produce the Medical Certificate as in the enclosed proforma. (Medical Certificate in triplicate is to be obtained from a single Medical Officer)

The Identity Certificate and Character Certificates are to be obtained from three different Gazetted Officers in the enclosed proforma.

No travelling or other expenses will be paid by the Department for attending the physical standard/ endurance test.

In the event of not reporting on the prescribed date for the above test, it will be presumed that you are not interested in accepting the offer of appointment in the department and your nomination will be treated as cancelled.
