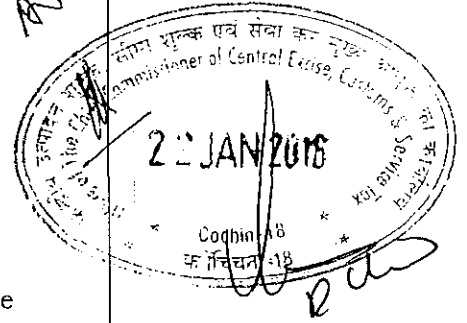


2. All efforts have been made to avoid any error in this compilation. Rectifications to the Civil List 2015 have been carried out on representations received through concerned controlling officers.
