Sub : Posting of Air Customs Superintendent/Air Customs Officers to C.S.I Airport, Mumbai against 25% Quota - Reg.

Willingness is invited from the Superintendents/Inspectors working in Central Excise Cochin Zone to draw a panel against the posts of Air Customs Superintendent/Air Customs Officer allotted to Cochin Central Excise Zone at C.S.I Airport, Mumbai in Airpool against 25% quota. The terms and conditions for selection and posting at C.S.I Airport, Mumbai as Air Customs Superintendent/ Air Customs Officer are as follows:-

1. The officer posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them at Mumbai from time to time.
2. The officer shall be considered as on deputation to the Airport, but no deputation allowance is admissible to him / her.
3. Normally, the period of deputation at the Airport is two years. However an officer at the Airport can be reverted before completion of 2 years without assigning any reason thereof.
4. The officer posted at the Airport will have to make his / her own arrangements for residential accommodations.
5. The officer will also be entitled to draw uniform and diet allowance as admissible under rules.
6. In the event of their promotion to the higher grade, the officer will be liable to be reverted back to their parent Commissionerate or posted anywhere as may be ordered by the competent authority in this regard.
7. The following officers are not eligible for consideration for posting at C.S.I Airport, Mumbai:
 - a. Officers transferred out of Airport / sensitive places on administrative grounds.

- b. Officers who have less than 3 years for retirement.
- c. Officers with less than 2 years cooling off period on their return from Airport/ UB Centres /DGRI/DGAE/ CB / ED (FERA)/EIB in terms of Ministry's instructions issued under F.No. A-25017/28/92-Ad.IIB dated 30.06.94 .
- d. Officers with Vigilance / Non-Vigilance cases
- e. Officers against whom penalty in a Vigilance case is operative.

Willingness may be called for from the eligible Superintendents/Inspectors showing the following particulars.

- i. NAME
- ii. PLACE OF POSTING
- iii. DATE OF BIRTH
- iv. DATE OF PROMOTION AS SUPERINTENDENT/INSPECTOR
- v. WHETHER WORKED IN ANY AIRPORT / DGRI / DGAE / NCB /ED (FERA) / EIB, IF SO DETAILS
- vi. WHETHER BELONGS TO SC / ST
- vii. SENIORITY IN THE SENIORITY LIST AS ON 01.01.2014
