 - (c) Certificates in support of your claim regarding experience and Certificates about Extra-Curricular Activities.
 - (d) Certificates in support of your claim as SC/ST/OBC/EX-Service/PH if applicable.
 - (e) Aadhaar Card.

 - (a) Completely filled in attestation form in triplicate with Identity certificate and Character certificate. Identity Certificate and Character Certificate are to be obtained from different Gazetted Officers in triplicate.
 - (b) You are required to undergo the prescribed Medical examination and to produce the Medical Certificate from a Medical Officer not below the rank of Civil Surgeon. Certificate to be produced in triplicate.
6. The department will not pay any travelling or other expenses to the candidates at the time of joining. In the case of Central Govt./State Govt./Autonomous Bodies employees and private sector employees they should obtain technical resignation/resignation from their parent department before joining this department.
7. In the event of not reporting before the prescribed date, it will be presumed that you are not interested in accepting the offer of appointment in this department and your nomination will be treated as cancelled.
8. If, however, within the specific period, a request is received from the candidate for extension of time, it may be considered by the Ministries/departments but extension beyond three months will not be granted liberally and it will be granted only as an exceptions where facts and

circumstances so warrant and in any case only up to a maximum of six months from the date of issue of the original offer of appointment and the offer of appointment would lapse automatically after the expiry of six months from the date of issue of the offer of appointment.
