

CIRCULAR

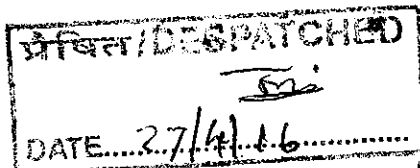
