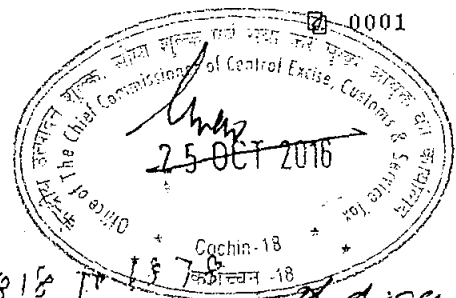

The Board had created Directorate General of Taxpayer Services (DGTS) vide order No. 02/Ad. IV/2015 dated 27.08.2015. To improve the ease of doing business, the Customs, Central Excise and Service Tax Department have been taking various measures.
