Sub: Posting as Air Customs Superintendent to Cochin International Airport, Nedumbassery against 25% quota for Central Excise Commissionerate - reg.

The following transfer and posting in the cadre of Superintendent of Central Excise is hereby ordered with immediate effect.

2. The officers are posted to Cochin International Airport, Nedumbassery for a period of two years from the date of joining in the new place of posting.

3. The terms and conditions for selection and posting at Cochin International Airport, Nedumbassery as Air Customs Superintendent are as follows:

(a) The officer posted at the Airport will be eligible to draw pay and allowances at the same rates admissible to them from time to time.

(b) He shall be considered as on deputation to the Airport, but no deputation allowance is admissible to him.

(c) Normally, the period of deputation at the Airport is two years. However an officer at the Airport can be reverted before completion of 2 years without assigning any reason thereof.


(d) The officer posted at the Airport will have to make his own arrangement for residential accommodation.

(e) The officer will also be entitled to draw uniform and diet allowance as admissible under rules.

(f) In the event of his promotion to the higher grade, the officer will be liable to be reverted to his parent Commissionerate or posted anywhere as may be ordered by the competent authority in this regard.

(g) He should join the new place of posting as ordered, failing which the posting order will be treated as cancelled.
