Sub: Extention of Deputation Period for the 4th year in Central Excise and Customs Commissionerate, Cochin Zone-reg.

In pursuance of letter C.No. II/13/11/2013 CC (KZ) I dated 23.12.2016 of Additional Commissioner (CCO), Cochin and letter C.No.II/13/4/2011-Estt.(CCA) dated 14.12.2016 of Deputy Commissioner (CCA), Chennai Zone, the deputation period of **Shri. S.Vaidyanathan, Superintendent of Central Excise** is extended for a further period of 1 year in Cochin Zone from **30.01.2017 to 29.01.2018**.
