
ORDER NO. 52/2017

Sub: Inter Commissionerate Transfer in the grade of Tax Assistant- Reg

In pursuance of letter C.No.II/13/3/2017 CC (KZ) I dated 06.03.2017 of the Chief Commissioner of Central Excise, Customs & Service Tax, Cochin Zone, **Smt. Nazia Sulthana N**, Tax Assistant of Central Excise, Customs & Service Tax, Coimbatore Zone is transferred to Central Excise, Customs & Service Tax, Cochin Zone as Tax Assistant as per Ministry's instructions issued vide F.No.A-22015/23/2011-Ad.III A dated 27.10.2011 and posted to Central Excise, Cochin Zone on Inter Commissionerate transfer basis. She should join the new place of posting on or before **31.03.2017** failing which this order will be treated as cancelled.

The above transfer is subject to the following terms and conditions:

- That her seniority will be fixed below the last Tax Assistant in Central Excise, Customs & Service Tax, Cochin Zone i.e. she will be treated as junior most in the cadre of Tax Assistant.
- No transfer TA/ joining time etc, will be admissible to her in connection with this transfer.
- She will not be considered for confirmation and promotion in the parent Commissionerate.
- She will be liable to be transferred anywhere within the jurisdiction of Central Excise, Customs & Service Tax, Cochin Zone.
- Her seniority in the cadre of Tax Assistant will be fixed and intimated in due course.
