ORDER NO. 59/2017

**Sub: Grant of financial up-gradation under Assured Career Progression Scheme - Reg.**

In accordance with the instructions contained in OM No. 35034/1/97-Estt(D) dated 09.08.1999 of Dept. Of Personnel & Training and clarification issued thereon from time to time on Assured Career Progression Scheme, Shri.K.B. Mohandas, Superintendent (now Assistant Commissioner) has been granted second financial up-gradation in the pre-revised pay scale of Rs. 8000-13500/- with effect from 17.11.2004.

2. The benefits released to Shri. K.B. Mohandas, Superintendent (now Assistant Commissioner) are subject to the outcome of the appeal filed by the CBI before the Hon'ble High Court of Kerala. It is further informed that the financial up-gradation, as personal to the incumbent for the stated purposes and restriction of the Assured Career Progression scheme for financial and certain other benefits (House Building Advance, allotment of Government accommodation, advances etc.) only without conferring any privileges related to the higher status (eg. Invitation to ceremonial functions, deputation to higher posts etc.), shall be ensured for grant of benefits under the Assured Career Progression Scheme.

3. The Officer will have to exercise option for pay fixation in terms of Department of Personnel and Training's OM dated 26.09.1981 and 19.11.1987 within one month from the date of order. The pay shall be fixed under the provisions of FR 22 (1) a (1), subject to minimum financial benefit of Rs.100/- as per the Dept. Of Personnel & Training OM No. 1/6/97-Pay.I dated 05.07.1999. The financial benefit allowed under the Assured Career Progression Scheme shall be final and no pay fixation benefit shall accrue at the time of regular promotion.

The financial up-gradation shall be purely personal to the officer and shall have no relevance to his seniority position.

4. It is also informed that this financial up-gradation shall be conditional to the fact that any officer, while accepting the said benefit, shall be deemed to have given his unqualified acceptance for regular promotion on occurrence of vacancy subsequently. In case he refuses to accept the higher post on regular promotion subsequently, he shall be subject to normal debarment for regular promotion as prescribed in the general instructions in this regard.
