## Sub: Promotion to the cadre of Inspector of Central Excise- Reg.

In pursuance to Ministry's letters F.No. A.32011/03/2015-Ad III A dated 02.08.2016, the following Senior Tax Assistants are hereby promoted, to officiate in the cadre of Inspector of Central Excise in level 7 of the Pay Matrix (Rs.44, 900-1, 42,400) as per 7<sup>th</sup> CPC corresponding to Pay Band of Rs. 9300-34800 plus Rs. 4600 (Grade Pay) plus such allowances as may be sanctioned by Government of India from time to time with effect from the date of joining the new post until further orders.

- 2. The officers should join the promoted post with immediate effect latest by 17.04.2017 failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
- 3. The above promotions are subject to the outcome of litigations pending before CAT (EB) /High Court/Supreme Court.
- 4. They will have to exercise option for pay fixation under FR 22 1 (a) 1 within a period of one month of joining the new post.
- **5**. The seniority of the officers in the new cadre will be fixed and placed as per DOPT's guidelines and Board's instructions.
- **6**. Specific posting orders to the officers will be issued in due course. The officers shall be liable to be transferred anywhere in the zone. However, pending issue of AGT 2017 the officers are posted to the respective Commissionerates where they are presently working until further orders.
- 7. Compliance reports should reach this office on or before 18th April 2017.
