Enclosed, please find a copy of letter F.No.916/02/PMC/HRD-ID/2016 dated 31.03.2017 from the DGHRD(Infrastructure & Welfare Wing), Central Excise & Customs, New Delhi.

2. Preparing for the rollout of the Goods and Services Tax (GST), The Central Board of Excise and Customs (CBEC) has started working on the proposals for re-organization of the offices at all levels and set timelines for administrative preparedness.

3. Accordingly, the new GST Commissionerates/Divisions & Ranges are proposed to be notified shortly as per the letter of DGHRD dated 13.05.2017 and in terms of letter dated 31.03.2017 of DGHRD, the officers posted to the respective formation may have to take charge latest by 1st of June, 2017. Since it is proposed to have a GST office at every Taluk of the State, the existing offices are likely to be re-located to such places notified by the Board.

4. In the meanwhile, it is proposed to move ahead with the process of implementation of the Re-organisation exercise. In this connection, please find enclosed the details of proposed draft GST Commissionerates, Division offices and



Range offices. The Commissionerates are requested to initiate action to identify suitable buildings for housing the GST offices in their jurisdiction and proposals may be sent to this office for taking up the matter with DG(HRD), if required, on a priority basis. In cases where administrative approval and expenditure sanction is required from the Ministry, proposals, complete in all respects, as per Infrastructure Manual, 2015 may be sent expeditiously to enable forwarding the same and to get the requisite approvals from the competent Authority.

5. Further, the requirement of funds, if any, for taking the office accommodation on hiring or purchase may also be communicated, separately.

6. Also, Division officers / Range officers under your charge may be requested to **prepare and forward a chart listing out all the files and documents/Registers etc. maintained/ available in the office** urgently and the formation wise list so received may be sent to **GST Cell-CC Office** so as to reach this office positively by **25th May, 2017**.

7. It is requested that the above matters may be accorded utmost priority having regard to the urgency of preparedness for the smooth roll out of GST.
