Sub: Inter Zonal Transfer in the grade of Executive Assistant- Reg

In pursuance of letter C.No.II/13/12/2015 CC (KZ) I dated 05.06.2017 of the Chief Commissioner of Central Excise, Customs & Service Tax, Cochin Zone, **Smt. Sukanya A. S**, Executive Assistant of Central Excise, Customs & Service Tax, Coimbatore Zone is transferred to Central Excise, Customs & Service Tax, Cochin Zone as Executive Assistant as per Ministry's instructions issued vide F.No.A-22015/23/2011-Ad.III A dated 27.10.2011 and posted to Central Excise, Cochin Zone on Inter Zonal transfer basis. Consequently; she is hereby directed to join the Cochin Zone.

The above transfer is subject to the following terms and conditions:

- That her seniority will be fixed below the last Executive Assistant in Central Excise, Customs & Service Tax, Cochin Zone i.e. she will be treated as junior most in the cadre of Executive Assistant.

- Her seniority in the cadre of Executive Assistant will be fixed and intimated in due course.

The officer should join the Cochin Zone on or before **19.06.2017** failing which this order will be treated as cancelled.
