Sub: Appointment to the cadre of Stenographer Grade-II - Reg

On acceptance of this Central Excise, Customs & Service Tax Commissionerate's Offer of appointment of even no. dated 01.06.2017, **Shri. Tumpella Rajeshwara Rao**, a candidate nominated by the Ministry for appointment as Stenographer Grade-II under **UR category** vide F.No.A.12034/SSC/04/2015-Ad.III (B) dated 03.05.2017 is appointed as Stenographer Grade-II in Central Excise, Customs & Service Tax, Cochin Zone on temporary capacity, subject to verification of character and antecedents, in Level - 4 in the pay matrix (Rs. 25,500-81,100) plus such allowances as may be sanctioned by the Government of India with effect from **13.06.2017 (F.N)**.

2. **Shri. Tumpella Rajeshwara Rao** is informed that he will be on probation for a period of two years from the date of appointment. The Appointing Authority may, if he thinks fit, extend the period of probation.

3. If on the expiration of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that the above candidate is not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that he will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate his services or pass such orders as he thinks fit.

4. The above candidate is also informed that his appointment is provisional and is subject to the caste/tribe certificate being verified through the proper channel and if the verification reveals that his claim to belong to SC/ST/OBC or in the case of OBC, not to belong to 'Creamy Layer' as the case may be, is false, his services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of the I.P.C. or any other Act, for the time being in force, for production of false certificate (applicable in respect of SC/ST/OBC candidates).
