4. The concerned Controlling Officers should issue/generate the relieving report/joining report, compulsorily, from **www.cepsonline.in/mypay** website using their login id and password.
5. Jurisdictional Commissioners are directed to include SSO/Email id of the officers while issuing intra-Commissionerate posting orders.
6. Controlling Officers shall also ensure that the officers are relieved only after proper relieving/handing over notes are mutually exchanged so as to ensure smooth transition.
