Sub: Voluntary retirement from service in respect of Smt. K.X. Mercy, Superintendent, Customs (Preventive) Commissionerate - reg.

In terms of the provisions of Rule 48 of CCS (Pension) Rules, 1972, the Principal Commissioner of Central Tax and Central Excise, Kochi is pleased to permit Smt. K.X. Mercy, Superintendent, Customs (Preventive) Commissionerate, Cochin to retire voluntarily from Government Service with effect from **01.10.2017** subject to all relevant conditions as applicable to Government servants under Voluntary Retirement Scheme pursuant to her representation dated 03.07.2017. However, since Smt. K.X. Mercy, Superintendent has not given the necessary 3 months notice period, the appointing authority has waived off the notice period of 3 months in terms of sub-rule 1-A (b) of Rule 48 of CCS (Pension) Rules, 1972 subject to the condition that the officer shall not apply for commutation of a part of her pension before the expiry of the period of notice of 3 months.

2. All dues in respect of Smt. K.X. Mercy, Superintendent, pending if any, may be recovered from her retirement benefits as per rules.
