Sub: Extension of Deputation period for the 5th year in Central Tax & Central Excise, Thiruvananthapuram Zone-Reg

In pursuance of letter C.No.II/13/11/2013 CC(KZ) I dated 23.10.2017 of Joint Commissioner (CCO), Thiruvananthapuram Zone and letter C.No.II/13/4/2011-Estt.(CCA) dated 12.10.2017 of Assistant Commissioner (CCA), Tamilnadu and Puducherry Zone, the deputation period of **Shri. S. Vaidyanathan, Superintendent of Central Excise** is extended for a further period of one year in Thiruvananthapuram Zone from 30.01.2018 to 29.01.2019.

2. The officer shall be liable to be repatriated to his parent Commissionerate earlier than the said one year period in the event of vacancy at the level of Superintendent against which he has been accommodated ceasing to be available in the Zone.
