

Sub: Extension of Deputation period for the 5th year in Central Tax & Central Excise, Thiruvananthapuram Zone-Reg

In pursuance of letter C.No.II/3/12/2008 CC(KZ) I dated 09.11.2017 of Joint Commissioner (CCO), Thiruvananthapuram Zone and letter C.No.II/13/25/2008-CCA.Estt. dated 31.10.2017 of Assistant Commissioner (CCA), Chennai Zone, the deputation period of **Smt. Asha K. Vijayan, Superintendent of Central Excise** is extended for a further period of one year in Thiruvananthapuram Zone from 17.12.2017 to 16.12.2018.
