
Sub: Extension of Deputation period for the 5th year in Central Tax & Central Excise, Thiruvananthapuram Zone-Reg

In pursuance of letter C.No.II/13/27/2013 CC(KZ) I dated 05.01.2018 of Additional Commissioner (CCO), Thiruvananthapuram Zone and letter F.No.II/3-6/Admn/CCO/MCX-I/2013 dated 18.12.2017 of the Deputy Commissioner (CCA), GST and Central Excise, Mumbai Zone, the deputation period of **Smt. Saraswathi Rammohan, Superintendent of Central Excise** is extended for a further period of one year in Thiruvananthapuram Zone from 03.02.2018 to 02.02.2019.
