**Sub: Appointment to the cadre of Havaldars on Compassionate Grounds

As per the findings of the Committee held on 08.11.2017 and on passing the physical test prescribed for Direct Recruit Havaldars, **Smt. Sayona Augustine** is appointed as Havaldar, on compassionate grounds in Central Tax and Central Excise, Thiruvananthapuram Zone under **General** category on temporary capacity, subject to verification of character and antecedents, in Level-1 in the pay matrix (Rs.18,000-56,900) plus such allowances as may be sanctioned by the Government of India with effect from **03.01.2018 (A.N)**.

2. **Smt. Sayona Augustine** is informed that she will be on probation for a period of **2(two) years** from the date of appointment. The Appointing Authority may, if he thinks fit, extend the period of probation.

3. If on the expiration of the period of probation or any extension thereof, as referred to in Para 2 above, the appointing authority is of the opinion that the above candidate is not fit for permanent absorption or if at any time during such period of probation or extension thereof, is satisfied that she will not be fit for permanent absorption on the expiration of such period or extension, the appointing authority may terminate her services or pass such orders as he thinks fit.
