Subject: Customs-Jurisdiction of Chief Commissioner of Customs & Central Excise Thiruvananthapuram, Commissioner of Customs, Cochin, Commissioner of Customs (Preventive) in Kerala- Issue of Public Notice -reg.

Attention of the Importers, Exporters, Customs Brokers, Custodians, Port Trust, Port Terminal Operators, Shipping Lines/Shipping Agents, Container Freight Stations (CFSs)/Inland Container Depots (ICDs) of Customs, Trade and other stakeholders is invited to Notification No.77/2014-Customs (NT), dated 16.09.2014, 78/2014-Customs (NT) dated 16.09.2017 and Notification No.82/2017 Customs (NT) dated 24.08.2017 and Notification No.85/2017 Customs(N.T.) dated 07.09.2017, as amended vide Notifications No. 86/2017-Customs (NT) dated 14.09.2017, 92/2017-Customs (NT) dated 28.09.2017, 99/2017-Customs (NT) dated 27.10.2017, 119/2017-Customs (NT) dated 28.12.2017 and as amended vide Notification No.03/2018 Customs(N.T.) dated 10.01.2018 issued by the Central Board of Excise & Customs, Department of Revenue, New Delhi, specifying the jurisdiction of Chief Commissioner of Customs & Central Excise, Thiruvananthapuram, Commissioner of Customs, Commissioner of Customs (Preventive), Additional Commissioners, Joint Commissioners, Deputy Commissioners/Assistant Commissioners of Customs and Customs (Preventive), Cochin, respectively for the purposes of the Customs Act, 1962 and the Rules made there under.

2. The above Notification specifying the jurisdictions will come into force from **15.01.2018.**

3. The new jurisdictions of the Chief Commissioner of Customs & Central Excise, Thiruvananthapuram, Commissioner of Customs, Cochin, Commissioner

4. The major changes effected consequent to the issue of the aforesaid notifications are as follows:

- The following Customs functions presently handled by the Officers of Central Tax and Central Excise will be handled by the Officers of Commissioner of Customs (Preventive), Cochin w.e.f **15.01.2018**.
 - i. International Airport and Air Cargo Complex at Thiruvananthapuram, Kozhikode and the proposed International Airport and Air Cargo Complex at Kannur.
 - ii. Kollam Minor Port, Kollam, Beypore Minor Port, Azhikal Minor Port, Kannur and the proposed Vizhinjam Port.
 - iii. Inland Container Depot, Kottayam.
 - iv. Customs related work in SEZ Formations.
 - v. Self Sealing/Factory Stuffing of Containers for export and acceptance of Bond/LUT
 - vi. Duty free imports by EOU/EHTP/STP Units, issuance of re-warehousing Certificate, bond to bond transfer, Collection of duty of Customs in case of disposal of Capital Goods (CG) and goods as such by the Unit. Execution of B-17 bond (Common bond for Excise & Customs), demand of duty of Customs in case of default in Net Foreign Exchange (NFE), non accountal of goods etc., collection of cost recovery charges, Merchant Overtime (MOT), etc. (Notification No.52/2003-Cus dated 31.03.2003).
 - vii. Duty free Imports/Imports at concessional rate of duty subject to end-use condition under Customs (Import of Goods at Concessional Rate of Duty for Manufacture of Excisable Goods) Rules, 2016-Notification No.32/2016-Customs (NT) dated 01.03.2016, Execution of Bond, Monitoring of Utilization and demand of Customs duty in case of default.

 - ix. Installation Certificate for goods imported under EPCG Scheme.


- x. Recovery of dues under Section 142 of the Customs Act, 1962
 - xi. Adjudication of offences and demand of Customs duty in respect of SEZs by the Central Excise Officers having jurisdiction over the SEZ.
 - xii. Brand Rate fixation of Customs duties in case of export of goods- Section 75 of the Customs Act, 1962.
 - xiii. The assessment of imported/exported goods and clearance of the goods at certain ports, ICDs/LCSs etc., away from major ports.
- **The Commissioner of Customs, Cochin and the Commissioner of Customs (Preventive) in Kerala are under the jurisdiction of the Chief Commissioner of Customs & Central Excise, Thiruvananthapuram, consequent to the issue of above Notifications.**


