In spite of repeated letters and reminders on the subject, it is noticed that the supervisory/controlling officers are not effectively monitoring the attendance of their subordinate officers.

2. Further, the monthly BAS reports, as required are neither sent in time nor properly prepared. The reasons for the shortfall in number of working hours put in by the officers is also not adequately substantiated.
3. It is once again exhorted to ensure that the subordinate staff attached to your office are mapped and linked through the AEBAS and mark their attendance in AEBAS without fail. Further your are hereby informed to forward monthly BAS reports in time with proper reasons in case of shortfall, if any.
4. Your attention is yet again invited to the provisions of **Rule (2)(i) of the CCS(Conduct) Rules, 1964**. Any dereliction in this regard shall be viewed seriously and shall reflect in your Performance Appraisal Report.
