Sub: Implementation of Judgement dated 20.09.2016 of the Hon'ble High Court of Kerala in W.P (c) No.21695/2010 filed by the Department against judgement dated 15.03.2010 in OA No. 433/2009 filed by Shri. K. I. Joshua & Others before the Hon'ble CAT Ernakulam Bench - Notional promotion as Tax Assistant -Reg

In pursuance of the Judgement dated 20.09.2016 of the Hon'ble High Court of Kerala in W.P (c) No.21695/2010 filed by the Department against judgement dated 15.03.2010 in OA No. 433/2009 filed by Shri. K. I. Joshua & Others before the Hon'ble CAT Ernakulam Bench, Shri. K. I. Joshua and Shri. N. I. Ziyad Hashim are deemed to have been notionally promoted to the cadre of Tax Assistant in the pay scale of Rs. 4000-100-6000 (as revised in the sixth pay commission) plus such allowances with effect from 02.12.2003 (date of passing the Computer Proficiency examination) as per Recruitment Rules notified vide Notification (G.S.R No. 381 (E) dated 2nd May, 2003 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i) on 5th May 2003.

2. They will have to exercise option for pay fixation under the Central Civil Services (Revised Pay) Rules, 2016 within a period of one month from the date of issue of the promotion order, and accordingly are entitled for pay fixation from the date of notional promotion and actually from the day they have started enshouldering higher responsibilities.
3. This is issued with the approval of the competent authority.
