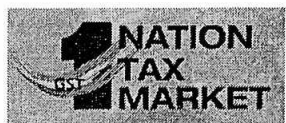

**Sub: Posting of Air Customs Superintendent/Inspectors to Trivandrum International Airport against 25% Quota - reg.**


Please refer to Ministry's letter F.No.A-11019/102/91-Ad.IV dated 21.10.1993.

2. In terms of the said letter, 1 (one) post of Air Customs Superintendent and 12 (twelve) posts of Air Customs Officers in Trivandrum Airport are to be filled from amongst Superintendents of Customs/Preventive Officers in your Zone.

3. Accordingly, you are requested to send a panel of officers for appointment against quota allocated to your Zone. The panel may be sent to this office latest by 12.08.2018.
