Sub: Inter Zonal Transfer in the grade of Tax Assistant- Reg

In pursuance of letter C.No.II/13/5/2018/CC(TZ)/I dated 31.07.2018 of the Chief Commissioner of Central Tax & Central Excise, Thiruvananthapuram Zone, Shri. Rakesh Ramabhadran (presently working as Executive Assistant) of CGST & Customs, Pune Zone is transferred to Central Tax & Central Excise, Thiruvananthapuram Zone subject to his reversion as Tax Assistant in Pune Zone as per Ministry's instructions issued vide F.No.A-22015/23/2011-Ad.III A dated 27.10.2011 and posted to Central Tax & Central Excise, Thiruvananthapuram Zone on Inter Zonal transfer basis. Consequently, he is hereby directed to join Thiruvananthapuram Zone.

The above transfer is subject to the following terms and conditions:

- a) That his seniority will be fixed below the last Tax Assistant in Central Tax & Central Excise, Thiruvananthapuram Zone i.e. he will be treated as junior most in the cadre of Tax Assistant.
- b) No transfer TA/ joining time etc, will be admissible to him in connection with this transfer.
- c) He will not be considered for confirmation and promotion in the parent Commissionerate.
- d) He will be liable to be transferred anywhere within the jurisdiction of Central Tax & Central Excise, Thiruvananthapuram Zone.
- e) His seniority in the cadre of Tax Assistant will be fixed and intimated in due course.

The officer should join Thiruvananthapuram Zone on or before **31.08.2018** failing which this order will be treated as cancelled.
