ORDER No.178/2018

Vide Circular F.No.A-22015/117/2016-Ad.IIIA dated 20.09.2018 by the CBIC, it has been clarified that the orders of IZT in the cadre of Inspectors issued on or after 23.12.2016 (date of enactment of RR 2016) will be non-est and accordingly any officer who has joined another zone in pursuance of such order shall be treated as **deemed on loan basis w.e.f 26.12.2016**. These officers shall be deemed to be posted on loan basis till **31.03.2019**, thereafter the officers shall stand relieved and be reverted to their Parent Zones.


