Applications are invited from eligible candidates for engagement as Special Public Prosecutor (SPP) to handle the cases relating to Central GST, Central Excise, Service Tax and Customs of Central Tax and Central Excise, Kochi, Kozhikode and Thiruvananthapuram Commissionerates, before the Subordinate Courts / Courts of Sessions and High Courts in the prescribed proforma (**Proforma - A**).

#### **A. Terms & Conditions**

- (1) **Number of Posts** : Three (3).
- (2) **Nature of work** : To represent the cases relating to Central Tax, Central Excise, Service Tax and Customs of Central Tax and Central Excise, Cochin, Kozhikode and Thiruvananthapuram Commissionerates before the Subordinate Courts / Court of Sessions / High courts.
- (3) **Eligibility** : The person should have been in practice as an advocate for not less than ten years who qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973.
- (4) **Tenure** : The first appointment of Special Public Prosecutor shall be normally for a period of 18 months.
- (5) **Termination of appointment**: The appointment/empanelment of the Special Public Prosecutor & Assistant Public Prosecutor would be terminable on one month's notice in writing by either side without assigning any reason.
- (6) **Fees & Allowances** : The same will be paid as per CBEC's letter F.No. 278A/82/2008 – Legal, dated 25<sup>th</sup> May, 2010 or as revised by Board from time to time.
- (7) **Other Terms & Conditions** : The appointment of the aforesaid advocate as Special Public Prosecutor shall be subject to the terms & conditions as laid down in CBIC's (formerly CBEC) letter F.No. 278A/82/2008-Legal dated 25<sup>th</sup> May, 2010 or as revised by Board from time to time.
